### Official trainings

The competition venue will be open to all the National Federations and secured from the Monday 12<sup>th</sup> May 2025 to Sunday 18<sup>th</sup> May 2025.

Participating National Federations will have access to Canoe Slalom official training sessions from Saturday 10<sup>th</sup> to Wednesday 14<sup>th</sup> May as follows :

- 1 slot of training per day and per nation.
- 23 to 24 boats per group.
- Different courses designs will be setup every day by the Organizing Committee.

Participating National Federations will have access to Kayak Cross official training sessions from Saturday 10<sup>th</sup> to Saturday 17<sup>th</sup> May as follows :

- 1 slot of of training per day and per nation
- 20-25 boat per group.

### Official training bibs

Athletes will be issued with a specific coloured bib for the duration of the 10-14 May training week. Team leaders/athletes are requested to collect bibs from reception prior to their first session on 9 May at 3:00 PM.

All slalom athlete bibs must be returned on <u>14 May</u>, <u>10:00 AM to 3:00 PM after the last</u> <u>slalom training session to the HOC office</u>. Should any bibs be missing, teams will be charged 50€ per bib. Competition bibs will not be issued until all bibs are returned or the 50€ per missing bib is paid.

Athletes competing in Kayak Cross can keep their training bib for the competition week to use on the legacy course training sessions. They must be returned to HOC office by the end kayak cross session on 17 May. For the Sunday kayak cross training, the athletes should have competition bibs.

Boat Racking : Boat racking will be available from 9 May in the team area.

**Team Area** : The Team Area will be open from 12 May for Competition weeks. Team tents will be ready from 10 May at the start of official trainings.

Team Tent Allocations : Team tent allocations will be confirmed on 9 May.

**Wifi** : it is available throughout the venue. Just select "Wifi\_Public\_Ile\_de\_Loisirs" and sign up for free/login.

**Drinking Water** : In line with our sustainability programme, no single use bottles will be used on the event (apart from for Doping Control). All individuals are requested to bring their own refillable bottles. For accredited personnel a drinking water tap is located in center of athlete village.

# Entries & participation fee



### Participation fee

The Participation fee will be charged per each athlete and team official for the Access Period, 10<sup>th</sup> – 18<sup>th</sup> May 2025. **The amount of the Participation fee is 160 € for the Access Period**.

The participation fee will include the following services: Athlete's Village, Official video service, Boat storage, Security, Internet Access, Access pass and parking, Information regarding the accommodation, Free training period, First aid, water safety during period competition, Flat-water training, Invitation letter for VISA applications. The accreditation fee must be paid in advance by 8<sup>th</sup> May 2025 via bank transfer to make the accreditation process more convenient.

**Reminder:** Entries or accreditation requests sent directly to the committee, or the competition organiser will NOT be accepted.

### Paris Low Emission Zone

To help improve air quality for everyone's health, the Paris Low Emission Zone (ZFE) is expanding from 1st January 2025. This year is an educational program and there will be no sanctions for all vehicles type.

#### Howeover Crit'air ticket still mandatory

#### Check my vehicle

Venue to Vaires-sur-Marne is not concerned to Paris low emission zone. But if you want crossing Paris area, some rules depend to you.

#### ZFE: vehicles classified 3 and more are restrictited

VOITURES, VÉHICULES UTILITAIRES ET 2 ROUES du lundi au vendredi de 8h à 20h (sauf jours fériés)

POIDS LOURDS 7 jours sur 7 de 8h à 20h

If you need to drive during restrited period, you have to ask for an 24H ZFE Pass : <u>Take a 24H pass</u>

### Insurance, Medical care and Anti-Doping



### First Aid

First aid for countries will be located between flat water area and slalom course (n°34) from 10<sup>th</sup> to 18<sup>th</sup> May. The NF advise all participants that emergency medical services will cover only emergency cases and that all participants are responsible to arrange medical insurance policy at their own cost.

#### Water safety

Rescuing in the competition area will be organised only during the competition days. Countries are responsible for their athletes during training period. However, there always will be someone in HOC office (n°g) to help contacting first aid or emergency if needed.

#### Medical insurance

The Organising Committee kindly asks all participants of the 2025 ECA Canoe Slalom European Championships to arrange medical insurance policy in their respective countries. All costs above the regular first aid and ambulance services are to be covered by this medical insurance policy. The Organising Committee will not cover any expenses in connection with hospital treatment.

### **Doping Control**

Doping control will be performed in accordance with the ICF/ECA Anti-doping requirements and WADA standards.



### Insurance, Medical care and Anti-Doping



#### Anti Doping Education

For the ICF World Championships, ICF World Cups and ICF Ranking Races and Continental Championships, every athlete, coach and support personnel MUST pass the relevant anti-doping online course on the Anti-Doping Education Learning platform (ADEL) corresponding to their role

Athletes entered in any ICF competition or Continental championships must complete the ICF's anti-doping education program or equivalent before competing or risk being denied entry to the competition. For more information please see: https://www.canoeicf.com/anti-doping-education
